Call to Order

Chair Coen called the meeting to order. The meeting took place at the Sanborn Center Ballroom B, located at 815 S. Alabama Ave., DeLand, Florida, having been legally noticed in the Daytona Beach News-Journal, a newspaper of general circulation in Volusia County, commencing at 5:04 p.m. The meeting was opened with The Pledge of Allegiance followed by a moment of silence.

Election of Officers

Open Floor for Nomination of Chair

Commissioner Craig nominated Commissioner Coen. Commissioner Manning nominated herself. There were no other nominations, and nominations were closed.

A paper ballot was utilized for a vote. Mr. Shephard and Ms. Tebo counted the ballots, and Ms. Tebo announced that Jennifer Coen was elected Chair.

Chair Continues with Nominations and Election of Remaining Officers Vice-Chair

Commissioner Pepin nominated Commissioner Manning. There were no other nominations, and by acclimation she was elected Vice-Chair.

Secretary

Commissioner Pepin nominated Commissioner Craig. There were no other nominations, and by acclimation she was elected Secretary.

Treasurer

Commssioner Accardi nominated Commissioner Pepin. There were no other nominations, and by acclimation she was elected Treasurer.

Approval of Proposed Amended Agenda

Motion 001 - 2024 Commissioner Craig moved to approve the amended agenda as presented. Commissioner Pepin seconded the motion. The motion passed 5-0.

Consent Agenda – Approval of Minutes Regular Meeting held November 16, 2023

Motion 002 – 2024 Commissioner Craig moved to approve the Consent Agenda. Commissioner Accardi seconded the motion. The motion passed 5-0.

EBMS November/December Reports – Written Submission

WVHA miCare Clinic DeLand/Deltona November/December Reports – Written Submission WVHA miCare Clinic Deland/Deltona 1st Quarter Report

WVHA miCare Clinic Population Health Annual Report

miCare Practice Manager Gretchen Soto pointed out that utilization remains strong at both clinics. She said that staff has been performing outreach to bring patients into the clinics more frequently. She added that they have been trying to educate the patients by mail outs and phone calls to ensure they know about all the services available to them as card holders.

Chair Coen thanked miCare for reviewing the copays as requested and noted the recommendation is that they remain the same.

Commissioner Craig noted that the patient comments were good in the quarterly report.

Ms. Soto explained the new clinic population health report and noted they are doing well with diabetic management. She clarified that most are type 2 diabetes.

Attorney Small asked about the benchmarks. Ms. Soto responded that with office visits, they want to be close to the benchmark or over; that for ER visits and hospitalization, they want to be much lower; and that they utilize Cedar Gate national reporting system to obtain the benchmarks.

Ms. Soto said she was working with the hospitals to follow up with patients in the clinic to keep them out of the hospitals.

Chair Coen pointed out the financial graph showing the medical costs divided by the members to give an average cost per member per month. She said the average cost has gone down from FY2022 to FY2023 despite seven percent inflation.

The House Next Door (THND) November/December Application Processing Reports

All reports were received into the written record.

Discussion Items

Powell & Jones WVHA FYE 2023 Audit Presentation – Brad Hough, CPA

Mr. Hough thanked Mr. Shephard and Ms. Tebo for providing the information they needed to perform the audit in a timely manner. He went through his PowerPoint presentation and highlighted various sections of the report for the Board. He stated there were no reported findings.

Commissioner Manning asked Mr. Hough if he had conversations with the commissioners. He responded that he did not. She requested that Mr. Hough contact the commissioners in advance of the report being written next year.

Chair Coen thanked Mr. Hough and said the audit report was received into the written record.

Mr. Shephard explained the processes utilized in performing the site visits. He noted that there were no deficiencies noted for the RAAO and SMA programs.

Farmworker Association of Florida, Inc.

Mr. Shephard stated that he recommended that their certification language be updated to include a statement that the applicant is personally known to the FWA as someone who is not Medicaid eligible and have FWA staff formally acknowledge the statement. Further, he recommended the FWA incorporate a process obtaining a written statement or affidavit from the applicant acknowledging they are not Medicaid eligible.

Attorney Small asked if FWA had implemented the suggestions. Mr. Shephard said he would follow up with FWA to ensure that they have implemented the suggestion.

THND HealthCard Follow Up

Mr. Shephard noted that THND had provided an income calculation sheet for 100% of the clients selected and all were eligible.

The site visits were received into the written record.

Approval of Non-Primary Care Funding Application

Ms. Tebo directed the Board to the red-lined changes on pages four, five, and eight that were included in the agenda packet.

Chair Coen suggested a change to page nine, number four (a) to rearrange the current verbiage and discussed rewording the audit language. Mr. Shephard advised that they should ask for the complete audit along with the letter.

After much discussion, there was consensus to approve the wording in 4a to read "Balance sheet and profit & loss statement for prior fiscal year and PDF of 990 or last filed tax return and, if audit was performed, complete audited financial statements including the management letter from an independent audit."

Motion 003 – **2024** Commissioner Craig moved to approve the non-primary care funding application for 2024-2025 as presented with the red-lined changes and the revised verbiage on page nine, number four (a) for release to the public on January 23rd. Commissioner Pepin seconded the motion. The motion passed 5-0.

Motion 004 – 2024 Commissioner Accardi moved to approve CAC appointments for Heidi Bello, Teresa Lake, and Jennifer Moore. Commissioner Craig seconded the motion. The motion passed 5-0.

Letters of Appreciation for CAC Members Lorna Owens, Taylor Hibel and Althea King

Motion 005 – 2024 Commissioner Accardi moved to authorize the Chair's signature on the letters of appreciation for Lorna Owens, Taylor Hibel and Althea King. Commissioner Craig seconded the motion. The motion passed 5-0.

Purchase of Tent and Table for Events (Commissioner Manning – Tabled on 11/16/23)

Commissioner Manning said it would be a good idea for the WVHA to have their own table rather than borrowing one for community events. She added that a tent would be valuable as many of the events are held outside.

Ms. Tebo said that she included quotes from Quality Quickprint for a custom tent and a commercial tent available on Amazon. She pointed out that the reason for the higher quote from Quality Quickprint is that it would be custom made with WVHA's logo. She said that Amazon had commercial grade tents in various colors, and they might order a blue one to match the custom WVHA tablecloth. She said that she included an eight-foot folding table, but a six-foot table could also work. There was consensus to order a blue tent.

Motion 006 – 2024 Commissioner Craig moved to authorize Ms. Tebo to spend up to \$400 for the purchase of a commercial grade tent and table. Commissioner Pepin seconded the motion. The motion passed 5-0.

Administrator Report

Ms. Tebo informed the Board that the process for filing Form 1 would be different this year, and that the Supervisor of Elections would no longer be involved. She added that the process would now be electronic, and they would receive emails from the Commission on Ethics for filing. She stressed that although municipal officials are now required to file Form 6, the new rule is not applicable to the WVHA Board of Commissioners.

She notified the Board that the new website was completed, and the Spanish application is now available as a fillable form. She said that she created a Facebook ad to direct people to click on the page for the health card application.

She advised the Board that One Voice for Volusia is hosting the 2024 Health & Human Services Summit at the Ocean Center on March 13th. She said it is free to attend, but there is a fee of \$100 for exhibitors. She added that One Voice for Volusia would supply a table and two chairs.

Commissioner Craig said she participated in the past with her non-profit, and she did not find it valuable.

Chair Coen said the purpose of the event is networking, and it is not geared towards finding potential card holders. She added that they could always attend individually as commissioners to network for free. There was consensus to discuss it at the next meeting.

Ms. Tebo noted that she provided the Board with an updated meeting schedule that included the CAC's choice of May 21st for the final ranking meeting.

Finance Report

November & December Financials Approval of Disbursements – Check Register & Estimated Expenditures

Mr. Shephard outlined the financials and estimated expenditures. He pointed out that there would be a \$10 million transfer from Ameris Operating to the Ameris Money Market account to take advantage of the favorable interest rate.

Motion 007 – 2024 Commissioner Pepin moved to approve, authorize, and warrant the payment of the bills outlined in the check register presented by James Moore & Co and estimated expenditures for the next month totaling \$11,383,441. Commissioner Manning seconded the motion. The motion passed 5-0.

Legal Update

Attorney Small stated he provided his annual overview of agreements and pointed out that EBMS has contracts with the network that automatically renew on September 30th unless one of the parties provides 90-day written notice of non-renewal. He suggested that it would be helpful to share the legal update with the CAC members.

He informed the Board that HB 7013 and SB 1058 are in process; that the House version removed the referendum provision this week, and it is expected to be removed from the Senate bill; that the bills contain a provision for term limits of twelve years; that the bills would require the WVHA to identify goals each year and then report back to Tallahassee each year if the goals were met; and that the bill is a priority for the Speaker of the House.

There being no further business to come before the Board, the meeting was adjourned at 7:10 p.m.
