Call to Order

Chair Coen called the meeting to order. The meeting took place at the Sanborn Center Ballroom A, located at 815 S. Alabama Ave., DeLand, Florida, having been legally noticed in the Daytona Beach News-Journal, a newspaper of general circulation in Volusia County, commencing at 5:04 p.m. The meeting was opened with The Pledge of Allegiance followed by a moment of silence.

Approval of Proposed Agenda

Motion 078 – **2024** Commissioner Manning moved to approve the proposed agenda. Commissioner Pepin seconded. The motion passed 3-0-2.

Consent Agenda – Approval of Minutes

Tentative Budget Hearing held September 5, 2024 Final Budget Hearing held September 19, 2024 Regular Meeting held September 19, 2024

Motion 079 – 2024 Commissioner Pepin moved to approve the Consent Agenda. Commissioner Manning seconded. The motion passed 3-0-2.

Citizen Comments

RAAO Representative Shannon Sargeant stated the open house anniversary celebration was rescheduled to October 25th; that he left event flyers on the agenda table for everyone; and that RAAO is working on a fast-moving grant that requires a letter from a public official that says RAAO provides services to the homeless.

Attorney Small suggested that RAAO provide more information about the grant and ask the Board to amend their agenda so that they can approve and authorize the letter.

Mr. Sargeant clarified that the grant is to request surplus computer equipment from the State of Florida such as workstations, monitors, and laptops to support RAAO's operations. He added that grant submission requires a letter from a public official certifying that RAAO provides services to the homeless or impoverished.

Motion 080 – **2024** Commissioner Pepin moved to amend the agenda to add discussion item 7E for the letter RAAO is requesting. Commissioner Manning seconded. The motion passed 3-0-2.

Reporting Agenda EBMS September Report – Written Submission WVHA miCare Clinic DeLand/Deltona September Report – Written Submission WVHA miCare Clinic DeLand/Deltona 4th Quarter Report – Written Submission

Commissioner Manning asked miCare Practice Manager Gretchen Soto how they see the patients. Ms. Soto answered that patients are seen in person or by phone visits. Commissioner Manning asked if patients are seen by a doctor or nurse practitioner. Ms. Soto answered that Dr. Gilmer oversees all the patients' charts but does not see patients; and that they have a mix of nurse practitioners and certified physician assistants that regularly see the patients.

Chair Coen asked Ms. Soto to clarify the percentages cited in the referrals section of the quarterly report on page four. Ms. Soto provided a brief outline and noted that they were reporting miCare referrals, and they were working with the TPA to gauge the specialty-to-specialty referrals. She said they included action items to improve the referral numbers; that they view the report as a beginning point in the process; and their goal is to meet the overall miCare benchmark of 36%.

Chair Coen said it seemed like they were slowly increasing the PAP numbers over time, and they were under budget in the pharmacy line item for FY 2024.

The House Next Door September Application Processing Report

Chair Coen asked COO Chris Booker about the referral noted at the bottom as Halifax or Change Healthcare. Mr. Booker said he would check on the wording and report back to the Board.

The reports were received into the written record.

Discussion Items

Florida Association of Special Districts Membership

Ms. Tebo listed the benefits of FASD membership and said she was particularly interested in the legislative and governmental advocacy provided. She pointed out that members joining FASD for the first time during October 1 - December 31 will get 50% off their annual dues for the entire year; that WVHA's dues for FY 2024-2025 would be \$2,250; that in future years, WVHA annual dues would be \$4,500 if they choose to remain membership; and that she recommended the WVHA join FASD.

Commissioner Craig said that the \$2,250 would be well spent in keeping WVHA up to date during the legislative session in Tallahassee. Commissioner Pepin agreed and said they would have a year to determine the value of membership.

Commissioner Manning asked if Ms. Tebo knew the people at FASD that would be in contact if they joined and if WVHA would receive information monthly or quarterly. Ms. Tebo responded that she had emailed two of the three FASD employees regarding membership; that information would be emailed to all FASD members as issues arise; that there would not be scheduled reporting; and that she expected notification from FASD as bills are introduced during session that might affect special districts.

Motion 081 – 2024 Commissioner Craig moved to approve WVHA membership in the Florida Association of Special Districts and authorize payment of \$2,250 for dues. Commissioner Pepin seconded. The motion passed 4-0-1.

First Amendment to FY 2023-2024 FDOH Dental Program Funding Agreement

Attorney Small stated that they have a proposed written agreement to confirm the amended funding limit that the Board approved at the last meeting authorizing an additional \$7,970.74; that the agreement codifies what the Board has already approved; and that he recommends approval as to form.

Motion 082–2024 Commissioner Pepin moved to approve the first amendment to FY 2023-2024 FDOH Dental Program Funding Agreement as presented. Commissioner Craig seconded. The motion passed 4-0-1.

Maturity of 1-Year and 3-Year CDs at Mainstreet Bank

Ms. Tebo stated that the WVHA has two CDs maturing on November 21, 2024; that CPA Webb Shephard recommends the Board open a one-year \$5M CD at the then current rate; and that they transfer the remainder of the two maturing CDs (approximately 650,000) into the Mainstreet Bank money market account.

Motion 083–2024 Commissioner Pepin moved to approve the WVHA opening a one-year \$5M CD and the transferal of the remainder of the two maturing CDs into the Mainstreet Bank money market account. Commissioner Manning seconded. The motion passed 4-0-1.

DeLand Christmas Parade Participation (Commissioner Manning)

Commissioner Manning stated that she wanted to participate in the Christmas parade and hand out small items to promote WVHA; that she planned on making WVHA signs for the car; that she had found multiple items online that could be used in the parade; and she thought it would be helpful to bring awareness of WVHA's health card program to the community.

Ms. Tebo itemized the various parade entry fees.

Attorney Small said he thought Commissioner Manning would enter free individually as a VIP and elected official, and it would simplify the process. He noted that all Board members could enter the parade individually as elected officials if they chose to do so without seeking Board approval.

Commissioner Manning asked for the Board's sponsorship of \$100 for the purchase of toys, bookmarks, or other items for promotional purposes. Commissioner Pepin voiced support for the idea but had reservations regarding plastics being thrown out and affecting the environment.

Motion 084-2024 Commissioner Craig moved to approve the use of \$100 in the advertising line item for safe and environmentally friendly parade promotional items. Commissioner Manning seconded. The motion passed 4-0-1.

Request from RAAO for WVHA Letter

Attorney Small said he came up with proposed language authorizing the Chair's signature on a letter stating that WVHA hereby confirms that RAAO is a contracted provider of HIV/AIDS testing, awareness, and counseling services to indigent residents, including those experiencing homelessness, of West Volusia County.

Mr. Sargeant said that the proposed language would fit the requirement for a letter from a public official that RAAO provides services to the homeless and impoverished.

There was discussion regarding additional verbiage of other social services. Attorney Small said he could add "and other social services" to his proposed language.

RAAO Founder Brenda Flowers requested that prescreening services be included in the letter.

Motion 085-2024 Commissioner Pepin moved to approve the letter requested from RAAO as described by Attorney Small and authorize Chair Coen's signature on the letter. Commissioner Manning seconded. The motion passed 4-0-1.

Administrator Report

Ms. Tebo said there was a good turnout for Orange City's National Night Out on October 4th at Mill Lake Park, and she talked to many parents about the Healthy Kids program. She said the website was updated to include the performance goals and measures adopted for the next fiscal year and information regarding the Medicaid Match dispute. She informed the Board that Gas Plumbing Services is scheduled to perform their work on November 13th and 14th at the DeLand clinic. She said she would be out from October 22nd through October 28th.

Finance Report September Financials Approval of Disbursements – Check Register & Estimated Expenditures

Ms. Tebo outlined the financial statements for the Board and pointed out the ER line item appeared to be over budget by about \$17,000. She explained that the financial statements are prepared on a modified cash basis, and payment from FY 2023 ER claims were included in the report. She stated that there would be a transfer of \$1.5 million from the Ameris Money Market account to the Ameris Operating account.

Chair Coen pointed out that they ended the year with a deficit of about \$600,000; that Webb Shephard's projections aligned with this fact; and that after accruals, there would be a \$2 million loss which would reduce reserves.

Motion 086-2024 Commissioner Manning moved to approve, authorize, and warrant the payment of the bills outlined in the check register presented by James Moore & Co and estimated expenditures for the next month totaling \$3,250,429. Commissioner Craig seconded the motion. The motion passed 4-0-1.

Legal Update

Attorney Small noted that Medicaid Match information on the website also includes the WVHA's

position statement from 2023 delivered to the County; that the issue has been ongoing since 2012; that this is our last opportunity in court to obtain a favorable resolution; that he urges the public to read the brief; and that concerned citizens cannot persuade the appeals court, but they can provide input to County council members and candidates.

Attorney Small stated that Volusia County announced that approximately \$4 million in opioid abatement funds would be available, and agencies should investigate the parameters and apply.

Chair Coen reminded everyone that the next meeting would be held November 21st.

Monthly Enrollment Report

In the month of October there were 300 client interviews conducted. Of these, 300 appointments were to assist with new applications and 11 to assist with pended applications from September to October. A total of 311 interviews were conducted.

For the month a total of 260 applications were submitted for verification and enrollment. Of these, all 260 were processed by the end of the month, leaving no rollovers to carry over into November for approval.

Of the 260 that were processed, 212 were approved, 11 denied, and 37 pended.

Currently applications are being processed, approved, and the client enrolled within 7 business days. Current enrollment with EBMS is taking up to 7-14 days to appear active in system.

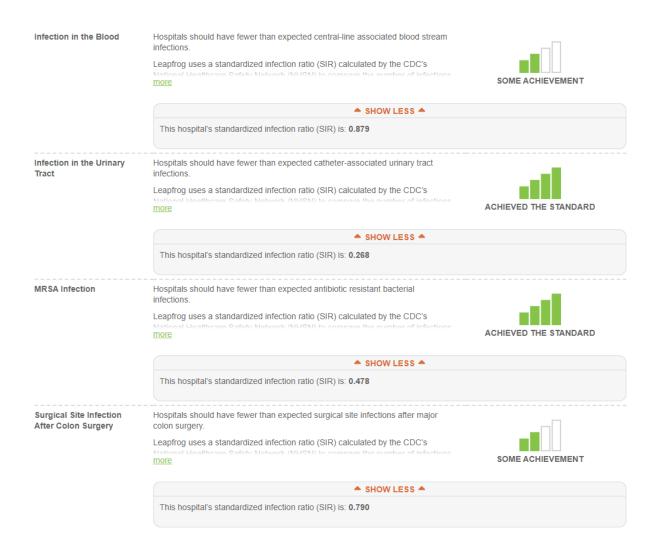
