#### **Hospital Quarterly Report**

AdventHealth DeLand – Lorenzo Brown, CEO and/or Kyle Glass, CFO AdventHealth Fish Memorial – Rob Deininger, CEO and/or Eric Ostarly, CFO

Mr. Kyle Glass, CFO addressed the Board and stated that he was the CFO now for both AdventHealth DeLand (AHD) and AdventHealth Fish Memorial (AHFM) as Eric Ostarly was moving to another position with AdventHealth in the Orlando market. Mr. Glass proceeded to update the Board as to how the hospitals have been handling the pandemic over March, April and May when they ceased all elective procedures, they kept their team members whole and they received their full pay. A lot of their team members have been able to work from home. He

updated the Board regarding their in-house positive Covid-19 staff members and how they handled this situation.

Mr. Glass stated that AHD and AHFM have continued their discussions with EBMS and have not yet reached an agreement with the TPA. They have accepted all of the terms proposed by EBMS and the WVHA Board, with the exception of not being reimbursed for their emergency department (ED) care. AHD and AHFM agreed to driving down the costs for the community and working well with EBMS in facilitating the clients back to the primary care clinics and telehealth services.

Commissioner Craig asked that if for some reason AHD and AHFM cannot reach an agreement with EBMS by October 1, 2020, what will the plan for a HealthCard (HC) member coming to their ED?

Mr. Glass assured the Board that every patient, regardless of their ability to pay, will receive the same level of care as those with commercial health insurance coverage. AHD and AHFM will try to connect this patient population with the EBMS primary care clinics and with their telehealth resources.

Commissioner Craig asked how would AHD and AHFM receive funding for these ED services?

Mr. Glass responded that AHD and AHFM would absorb those costs. They also try to qualify these patients for charity care and/or Medicaid.

Commissioner Craig asked what if the HC member needs to be admitted?

Mr. Glass said that they would still receive the care they needed and would still be admitted and taken care of.

Commissioner Craig asked how the HC member would be impacted if they required further specialty care?

Mr. Glass explained that the hospital would still assist in coordinating with the specialists in network with that patient for that continued care.

5:29 p.m. Commissioner Andy Ferrari joined the conference call.

Commissioner Craig asked Mr. Glass, if the hospitals do not secure a contract with EBMS for these hospital services and the specialists, and October, November, December comes to pass with numerous HC members receiving services at both hospitals, how does the hospital justify not entering into a contract with EBMS to continue to take care of these patients?

Mr. Glass explained that the one term the hospitals have not been able to come to an agreement on with EBMS is the lack of reimbursement for ED care.

Dr. Andrew Murray, CMO, EBMS stated that if they could get to a point of agreeing upon this ED responsibility coverage and AdventHealth could come to terms with the rest of the negotiations, then EBMS could finalize these negotiations with AdventHealth. Regardless of reaching an agreement with AdventHealth, EBMS will coordinate care with the hospitals on behalf of the WVHA HealthCard members.

# Contractual Utilization Reports to the WVHA Board of Commissioners Peter Willems, Director of Operations, Hispanic Health Initiative (HHI)

Mr. Peter Willems, Director of Operations, HHI stated that he was available to answer any questions that the Board might have regarding their written submission.

# Christina Russo Walters, Attorney, Community Legal Services of Mid-Florida (CLSMF)

Ms. Christina Russo Walters, Attorney, CLSMF stated that she was available to answer any questions that the Board might have regarding their written submission.

Chair Guzman asked Ms. Walters to speak about their outcomes.

Ms. Walters explained that during fiscal year 2019-2020 CLSMF had 21 WVHA client cases. They have closed 15 of those cases and 10 clients have secured Social Security, Medicare and Medicaid coverage and no longer need the WVHA HC. Since they first received WVHA funding, they have removed 20 WVHA HC members from the WVHA rolls, resulting in a financial benefit of \$7,030.50 in monthly client benefits, \$170,279.63 in retroactive benefits for the clients.

#### **Discussion Items**

Review Proposed Budget 2020-2021 WVHA Commissioner's Proposed Budgets 2020-2021 2020-2021 CAC Ranking Recommendations

Chair Guzman opened the floor for Board discussion regarding the proposed 2020-2021 budget.

Commissioner Craig stated that she wanted to go with the rolled-back rate at this time.

Commissioner Hill was going to wait to see what the pleasure of the Board is going to be.

Commissioner Ferrari was going to wait and weigh in during the budget hearings.

Commissioner's Guzman and Manning had already presented their budget recommendations (attached).

Mr. Cantlay reviewed the proposed 2020-2021.

Commissioner Hill asked Mr. Cantlay to reduce the overall current year hospital budget by roughly 40%.

Mr. Cantlay responded that would amount to roughly \$3.6 million or \$3.7 million. Removing the ED funding would also result in a budget reduction for that hospital budgeted line item.

There was Board consensus to place \$3 million in the hospital budgeted line item.

There was Board consensus to place \$3 million in the primary care and pharmacy budgeted line item.

There was Board consensus to place \$3.3 million in the specialty care and lab services budgeted line item.

Mr. Cantlay explained the historical calculations used to determine each taxing districts and the County of Volusia's share for County Medicaid.

The Board then discussed the funded agencies and their funding requests.

Chair Guzman reduced The House Next Door from \$110,000 down to \$100,000.00. Fund Community Legal Services of Mid-Florida (CLSMF) at their original request of \$95,958.00, as she had previously reduced it and reversed her reduction due to their utilization report and how much they have saved the WVHA in costs. For Hispanic Health Initiative (HHI) they had requested \$95,700 and she reduced that budget to \$75,000, which is the same as the funding HHI received for 2019-2020 and based upon the CAC recommendations.

There was Board consensus that agreed with Chair Guzman's recommendations.

There was much Board discussion regarding Rising Against All Odds (RAAO) funding for Prescreening services in reducing their funding to \$30,000 from \$50,000. After much back and forth, there was a majority of the Board who agreed to place \$40,000 in RAAO's prescreening budgeted line item, with dissent from Commissioner Manning who wanted to leave it budgeted at \$50,000.

Mr. Cantlay recommended that the Board consider taking \$1.1 million out of reserves to cover those onetime only expenditures, like the two new clinics that will be opened in the South and North end of West Volusia during the EBMS Phase 2 transition.





In the month of August there were 330 appointments to assist with new applications and 20 appointments to assist with pended applications from July-August. For a total of 350 Phone Interviews with clients.



Summarized below are updates on active legal matters/issues for which some new information has become available since my last legal update. This Memorandum will not reflect updates on matters resolved by a final vote of the Board and thereby already summarized in the August 20, 2020 Meeting Minutes.

#### I. Funding Agreements for 2020-21:

Please note that each Board member is responsible for making his or her own independent determination about whether the terms of a particular contract is consistent with the public interest. Counsel, EBMS as well as the accounting and administrative team at DRT, PA, are available to answer your questions and offer counsel about accounting and business or legal matters, each respectively; but, the Board retains the ultimate authority to approve or disapprove the terms of all proposed agreements after due consultation.

Based on the approved 2020-21 Tentative Budget, counsel circulated proposed "redlined" drafts of funding agreements to each of the funded providers. Counsel also circulated copies of the redlined drafts to members of the Board and to accounting and administrative staff at DRT. To the extent agreeable, suggested changes were incorporated into final drafts and circulated to the agencies for final review and execution. Unlike past years where some final agreements were still pending for further negotiation well into spring of the fiscal year, counsel expects to recommend approval of all agreements as to form.

It is noteworthy that this year only one of the CAC reviewed and recommended agencies has not provided any comparable rate information concerning the "AVERAGE COST/UNIT OF SERVICE WITH COMPARATIVE REIMBURSEMENT" section of the Funding Application. Except for Hispanic Health Initiative ("HHI"), all agencies were able to provide some comparable rate information (even if it required looking at rates paid in states other than Florida). Even when counsel suggested additional research in more progressive jurisdictions like New York and Illinois, HHI represented that it had searched but could not find any such information. Counsel is willing to defer this year to the continued validity of past negotiations with HHI over its reimbursement rate, but notes this incomplete information for the Board's consideration of whether it has an adequate factual basis for determining whether the proposed reimbursement rate is competitive.

It is also worth noting that the following non-discrimination clause which tracks State Law has been a part of all WVHA funding agreements since I was first retained to be the Attorney. Unless specifically told otherwise by a majority of this current Board, monitoring compliance with this and other provisions in the funding agreements has always been a part of my Attorney responsibilities: "Non-discrimination. Grantee shall not discriminate on the basis of race, color, religion, sex, national origin, age, disability or marital status."

With those clarifications, counsel anticipates recommending approval as to their legal form all proposed agreements:

- J. The Healthy Start -Family Services Coordinator—Deltona
- K. The House Next Door Mental Health Services
- L. The House Next Door—Eligibility Determination Services
- M. The Neighborhood Center of West Volusia "Access to Care"
- N. The Neighborhood Center of West Volusia "Health Care Navigation"
- O. Volusia County Health Department—Florida Department of Health (Dental Care)

# II. Legal Context for Budget Workshop/TRIM Procedure [Tax/Budgeting] [See new info. in italics and bold]

Please note that the Authority's budget process is governed by the Truth in Millage ("TRIM") process as set forth in Chapter 200, Florida Statutes and the related Department of Revenue compliance regulations. In general, TRIM requires that taxing entities such as the Authority hold two public hearings for open discussion on their proposed millage rate and proposed budget. Such public hearings must first deal with any increase in millage over the statutory rolled-back rate (RBR) necessary to fund the proposed budget, if any, and the specific purposes for which taxes are being increased. The millage rate must be adopted first and then the budget must be adopted with a separate vote. Notices for the first public hearing ("TRIM Notice") is mailed to taxpayers by the County Property Appraiser on the Notice of Proposed Property Taxes. Notice for the second public hearing is handled by the Authority with a newspaper advertisement in a statutorily mandated format and publication deadline.

For Board member personal vacation scheduling purposes, please note that the Authority's TRIM budgeting process usually starts in July coincident with the Property Appraiser's certification of the tax roll and ends in late September with a final budget hearing and submission of certifications of compliance to the State's TRIM Compliance Office. Therefore, even though tentative dates have already been voted upon (see below in Paragraph H *infra*),

Board members should maintain as much flexibility as possible in their September schedules in order to ensure a quorum and whatever majority is necessary to satisfy the TRIM requirements.

For most years since 2007 including for the current tax year, the Board has voted to adopt millage at the "rolled-back rate" ("RBR"), which is the rate calculated with a statutory formula to allow the Board to raise the same amount of revenue as it did in the immediate past tax year with a simple majority vote. Refer to counsel's 9/17/2014 for further historical summary of final millage votes.

The following are descriptions of the exceptional years where the Board has voted to set its final millage rate either below or above that statutory rolled-back rate, which meant a tax decrease or tax increase in layman's terms:

Regarding the 2019-20 budget year, the TRIM Final Budget Hearing was held on Thursday, September 26, 2019, and the Board voted 3-1-1 to set its final millage at 1.908 mills with a separate 3-1-1 to adopt the Authority's 2019-20 final budget of \$19,556,988. Therefore, the 2019-20 tax year's millage of 1.908 mills was a 5.563% decrease over the 2.0204 mills rolled-back rate.

Regarding the 2017-18 budget year, the TRIM Final Budget Hearing was held on Tuesday, September 26, 2017, and the Board voted 4-0-1 to set its final millage at 2.366 mills with a separate 4-0-1 to adopt the Authority's 2017-18 final budget of \$20,023.304.00. Therefore, the 2017-18 tax year's millage of 2.366 mills was a 58% increase over the 1.4966 mills rolled-back rate.

Regarding the 2015-16 budget year, the TRIM Final Budget Hearing was held on Thursday, September 17, 2015, and the Board voted 5-0 to set its final millage at 1.6679 mills with a separate 5-0 to adopt the Authority's 2015-16 final budget of \$16,741,063.00. Therefore, the 2015-16 tax year's millage of 1.6679 mills was a 10% decrease over the 1.8532 mills rolled-back rate;

Regarding the 2014-15 budget year, the TRIM Final Budget Hearing was held on Thursday, September 25, 2014, and the Board voted 4-0-1 (vacant) to set its final millage at 1.9237 mills with a separate 4-0-1 (vacant) to adopt the Authority's 2014-15 final budget of \$15,989,676.00. Therefore, the 2014-15 tax year's millage of 1.9237 mills was a 15% decrease over the 2.2632 rolled-back rate;

Regarding the 2013-14 budget year, the TRIM Final Budget Hearing was held on Thursday, September 19, 2013, and the Board voted 5-0 to set its final millage at 2.3759 mills with a separate 5-0 to adopt the Authority's 2013-14 final budget of \$17,453,695.00. Therefore, the 2013-14 tax year's millage of 2.3759 mills was a 1.5% decrease over the 2.4121 rolled-back rate;

Regarding the 2009-10 budget year, the TRIM Final Budget Hearing was held on Tuesday, September 22, 2009, and the Board voted unanimously to set its final millage

at 1.745 mills with a separate unanimous vote to adopt the Authority's 2008-09 final budget of \$15,680,000.00. Therefore, the 2009-10 tax year's millage of 1.745 mills was a 2.04% decrease over the 1.7813 rolled-back rate;

Regarding the 2007-2008 budget year, the TRIM Final Budget Hearing was held on Wednesday, September 12, 2007, and the Board unanimously voted to set its final millage at 1.2619 mills with a separate unanimous vote to adopt the Authority's 2007-08 final budget of \$18,414,937.00. Therefore, the current tax year's millage of 1.2619 mills is the same as the final millage adopted for 2006-07, but it represented a 10.37 percent increase over the statutory rolled-back rate of 1.1433 mills.

On May 21, 2020, the Volusia County Property Appraiser sent the Authority official notification that based on its "pre-preliminary estimate", the total taxable value of property in the Authority's tax district is \$11,686,105,072, which represents a net change of approximately +11.09% from 2019 pre-preliminary estimated taxable value (10,519,658,760).

Regarding the 2020-21 budget year, the TRIM Tentative Budget Hearing was held virtually on Thursday, September 10, 2020, and the Board voted unanimously to set its tentative millage at the rolled-back rate of 1.7569 mills with a separate unanimous vote to adopt the Authority's 2020-21 tentative budget of \$19,750,000.00. At this juncture, the 2020-21 tax year's millage of 1.7569 mills represents a 0.00% increase over the 1.7569 mills rolled-back rate.

Most steps in the TRIM process have already occurred. The following additional steps are required to complete the 2019-2020 TRIM process:

- A Pursuant to the Board's Resolution for Publication, Monday, September 21 is the tentatively scheduled date for publication of the Final Budget Hearing which is proposed to occur in a special meeting on Thursday, September 24, 2020 at 5:05p.m, followed immediately by a regular meeting scheduled for that same date.
- B Within 3 days of the Final Budget Hearing, the Authority (via DRT) must forward the resolution adopting the final millage rate to the Property Appraiser.
- C Within 30 days of the Final Budget Hearing, the Authority (via DRT) must submit its TRIM Compliance package (DR-422).
- III. Implementation of Email and Text Messaging Public Records Policy [See new info. in italics and bold] [Refer back to Legal Update Memorandum dated 5/21/2020 for additional background details.]

As requested during the November 14, 2019 Regular Meeting, counsel has reviewed relevant Florida Attorney General Opinions and case law and reviewed comparable local government policy to develop the following Email and Text Messaging Public Records Policy, adopted 1/16/2020:

<u>Issue:</u> How should WVHA direct its individual Board members, funded agencies and contracted agencies and professionals to preserve electronic communications and other documents that may constitute "public records" under the Florida Public Records Law,

#### Chapter 119, Florida Statutes?

<u>Conclusion</u>: In order to comply with the Florida Public Records Law, any email or text message which involves WVHA official business and it of a non-transitory nature, as explained above, must be preserved as a "public record" in accordance with the General Records Schedule. Board members, funded or contracted agencies and contracted professionals are hereby strongly discouraged from using personal email accounts and cell phones to conduct official WVHA business unless it is only "transitory" as explained above. Effective as soon as such accounts are generated by WVHA's contracted Public Records Custodian and technical access is made available, Board members and contracted professionals are expected to utilize email accounts on the westvolusiahospitalauthority.org domain for purposes of sending and receiving emails to conduct WVHA official business. When it is necessary to utilize personal accounts because the matter is time sensitive, individuals are encouraged to forward the email to Ms. Long for preservation in accordance with the General Records Schedule. If there is any question at all in the Board members', funded or contracted agent's mind about whether the email or text massage is a public record, the question should be discussed with Ms. Long who shall consult State officials to determine the appropriate retention schedule. If the person communicating about WVHA business on non-WVHA email accounts or telephones is not able to save those messages on their company or personal computer or phone equipment, they should contact Ms. Eileen Long at DRT, which is WVHA's designated Public Records Custodian to make arrangements for forwarding them to Ms. Long for their proper preservation.

The Board adopted this policy at its May 21<sup>st</sup> Regular Meeting and clarified its preferences for the type of email accounts during its August 20<sup>th</sup> Regular Meeting. This placeholder will remain pending full implementation.

IV. WVHA as Plaintiff in Federal Multidistrict Litigation for National Prescription Opiate Litigation, James Vickaryous, Managing Partner of Vickaryous Law Firm. [See new info. in italics and bold]

Counsel talked preliminarily with Jim Vickaryous, the Managing Partner of the Vickaryous Law Firm about WVHA retaining his law firm to represent WVHA on a contingency basis and file a lawsuit on behalf of WVHA in the federal multidistrict litigation for national prescription opiate litigation. Attorney Vickaryous plans to present a formal proposal to explain the details, but in a nutshell the proposed representation would offer WVHA a seat at the table among many other governmental and private entities around the nation that are suing pharmaceutical companies. These lawsuits are seeking to recover damages related to the substantial health care and prescription costs that have been paid to treat residents who became addicted to opioids. As of this writing, counsel has not yet received a draft of the proposed retainer agreement or the presentation materials. Attorney Vickaryous has indicated in an introductory call that if desired, WVHA would become one of several Florida based local government clients which his firm would represent. The contingency basis of the representation would provide that the Vickaryous Law Firm would be paid 20% of any net recovery after costs and WVHA would keep the remaining 80%. Attorney Vickaryous believes that it would be important to get WVHA's lawsuit on file as soon as practicable before

settlement talks begin and conclude concerning a Tier I lawsuit that is scheduled for trial in Ohio during October, 2019. Attorney Vickaryous believes that the defendants in that lawsuit may want to negotiate a global settlement of all pending lawsuits and it would be advantageous for WVHA to have a seat at that table, particularly in light of the substantial annual budget expenses being paid to SMA and for prescriptions that are directly related to the opioid epidemic. Counsel expects to receive and review the details prior to the March meeting and have a recommendation as to the form of the retainer agreement at that time. As an overall matter, the proposal sounds like a potential opportunity for WVHA to recoup substantial taxpayer dollars, but it may take some time before any recovery is obtained. Following the Board's authorization of Chair Craig to sign the proposed contingency agreement subject to a clarification that the net of any recovery to WVHA only be reduced to reimburse "reasonable" attorney's fees, Chair Craig has executed the revised agreement and it is being circulated for signatures by all the retained co-counsel. As previously emailed, WVHA's complaint in the national opioid litigation was initially filed in federal court in the Middle District of Florida on September 10, 2019. On September 26, 2019, that case was transferred to the Northern District of Ohio where is has been consolidated with the thousands of other pending cases in that multidistrict opioid litigation.

Counsel received the following update from class counsel in July/August, 2020:

#### A. Purdue Bankruptcy

As we have previously explained, in order to participate in the Purdue bankruptcy, a Proof of Claim form must be filed on behalf of your entity. We have already filed a Proof of Claim form [generously estimated at \$32,009,971.00] on your behalf.

Now, based on recent developments in this bankruptcy, we plan to amend these forms to include a minimum valuation for your claim. In other words, we will be setting forth a specific monetary amount for your claim within this bankruptcy. We, along with the members of the Plaintiff Executive Committee and the Bankruptcy Ad Hoc Committee, believe that this is an important step to ensure that the claims of local governments are provided appropriate priority as creditors.

To estimate the minimum value for local government claims, the Ad Hoc Committee has worked with Ted Miller, an internationally recognized safety economist with Pacific Institute for Research and Evaluation (PIRE), who has developed a model that estimates monetary relief, including damages and abatement costs, which cities, counties, and municipalities across the United States (the "Municipality Claim Model") may assert against the Debtors.

To be sure, this "minimum valuation" is not the amount of money that you would receive from the Purdue Bankruptcy. The total valuation to all governmental entities is estimated to be in the area of \$2 trillion, and of course only a very small fraction of that amount could ever be available for distribution. Therefore, any amounts that are actually received by local governments will be significantly less than the "minimum valuation" we submit.

#### V. General Compliance with the Sunshine Law [See new info. in italics and bold]

The Government in the Sunshine Law, section 286.011, Florida Statutes, provides in pertinent part:

\*All meetings of any board or commission . . . of any agency or authority of any county, municipal corporation, or political subdivision . . . at which official acts are to be taken are declared to be public meetings open to the public at all times, and no resolution, rule, or formal action shall be considered binding except as taken or made at such meeting.\*

It is impossible to summarize all relevant points of the Sunshine Law, but please note that courts uniformly interpret this provision as prohibiting two or more members of the same board or commission from talking about or discussing any matter on which *foreseeable* action will be taken by the pubic board or commission. (If your conversation with another board member concerns personal or business matters unrelated to the Authority, the Sunshine Law does not apply)

Please note that the Sunshine Law DOES apply to "off-the record" chats during meetings or during breaks, written correspondence, telephone conversations and e-mails exchanges between two or more board members if such communication concerns matters likely to come before the Board; provided however, it is permissible for one board member to send correspondence to the rest of the board outside of a public meeting as long as this correspondence does not result in replies or other back and forth exchanges until a public meeting is convened for such discussion and also the correspondence is made available to interested members of the public.

The Sunshine Law also prohibits nonmembers (staff, lawyers, accountants, and members of the public) from serving as liaisons between Board members concerning matters likely to come before the Board.

With the increased use of social media accounts, including Facebook and other community and political blogs, Board members should be mindful of the following Florida Attorney General guidance before posting on Facebook, or other blogs an opinion or viewpoint on matters likely to come before the Board. In AG Opinion 08-07, the Florida Attorney General concluded that the use of a website blog or message board to solicit comment from other members of the board or commission by their response on matters that would come before the board would trigger the requirements of the Sunshine Law. As stated therein:

"While there is no statutory prohibition against a city council member posting comments on a privately maintained electronic bulletin board or blog, ... members of the board or commission must not engage in an exchange or discussion of matters that foreseeably will come before the board or commission for official action. The use of such an electronic means of posting one's comments and the inherent availability of other participants or contributors to act as liaisons would create an environment that could easily become a forum for members of a board or commission to discuss official issues which should most appropriately be conducted at a public meeting in compliance with the Government in the Sunshine Law. It would be incumbent upon the commission members to avoid any action that could be construed as an attempt to evade the requirements of the law."

With the approach of the upcoming election, all candidates should take note that once a candidate becomes a "members-elect" of the WVHA Board of Commissioners, the member-elect becomes subject to the Sunshine Law in the same manner as Board members who are currently in office.
